Notes for THOMAS CURRICOMB:

The Brothertown movement began with a general meeting of Indians at Mohegan, March 13, 1773, to hear and discuss the proposal. After several days of debate, they formed a committee, consisting of one representative from each Indian tribe and directed them to go to Oneida with their request for land. The Indians were unable to send their representatives at once, as they had hoped, but later that summer Joseph Johnson sent an appeal to Sir William Johnson, Superintendent of Indian Affairs, and received his promise to secure land for them from the Oneidas. Joseph Johnson then sent letters to the seven Indian communities describing the status of the project and urging others to join:

Farmington, Octr 13th A.D. 1773

This once more, we of the Tribe at Farmington send greeting to all our Indian Brethren at Mohegan, Nihantuck, Pequitt, Stonington, Narragansett and Montauk, Brethren. We love you, and wish your wellbeing both in this Life and that which is to come. We ask your Serious Attentions a Moment. Dear Brethren, with humility we undertake to write you, begging that ye would remember the Affair of which we so earnestly talked last Spring at the town of Mohegan. We beg that ye would this once more take this Affair under your deliberate Considerations, let it not drop through since we have encouragements on every side. We have encouragement from His Honour, Sir William Johnson, Baronet, and thing look promising. Let us take Courage friends and let us step forward like men. We beg that ye would by all means Send a Man out of Each Tribe, that they may go with us, and Seek a Country for our Brethren, is it not worth while. Surely it is. be so good as to show yourselves me, for General Johnson Expects us at his house [the] last of this month, and if we do not make our appearance, he will think that we are only talkers, and not worthy of Notice. how foolish shall we feel if we be despised by General Johnson. But dear Brethren, we will not multiply words, seeing that ye are men, and it is to be hoped wise men. Consider of things, and do that which is right, by no means be discouraged, but dear Brethren, let us put our trust in that God who ruleth in the Armies of Heaven, and doeth his pleasure among the Inhabitants of this lower World - if God be for us this is Enough, he can comfort us Even in a Wilderness. let us consider of our Condition, let us think of our Children, let us think of time to come. We mention these things to put you in Remembrance. Brethren, if the men chosen last spring be backward to go to the Mohawk Country be so good as to Send others in their room, and Encourage one another. if Money is scarce, let us try to carry little provisions in our Packs, which will be of considerable help, let the men that go try to get the good will of the Women and let the kind women make little Yoke-hegg. We will try to help them with little Provisions when they go from here. our kind Women send a word of Encouragement and say that they will make a little yoke hegg to give to the travelers.

So we must End. Wishing you all well: and we would beg that those men shall go, come to our town be sure

by the 23d day of the Month, as we purpose to Set of from here the 25th of October, or of this month. Let all Christians pray for us every Day. So farewell. We whose Names are underneath are united in those things that are contained in this Letter. Sam adamas Joseph Johsons Andrew Corcemp Scripsit Charles Wimpey Moses Sanchuse Thomas Corcemp Solomon Mossuck Daniel Mossuck

Probably a copy of the letter sent to Mohegan. With the exception of Moses sanchuse, all the signers are men whose families Johnson boarded as schoolteacher at Farmington; see his diary.

This was a prominent Indian family of the original Tunxis stock. Andrew Correcompt owned several tracts of land in Farmington. He served during the French wars in Capt. Aaron Hitchcock's company in 1756, in Col. Nathan Whiting's company in 1760, and in Capt. Samuel Dimock's company, N.Y. troops, in 1762.

Andrew Curricomb (Andrew), born in 1747, was prominent in the emigration plans, and an early settler at Brothertown. After the Revolution, in which he was said to have served while at West Stockbridge, Mass., he returned to Oneida with his family. He settled on lots 120 and 121, which were divided among his heirs in 1818. His wife's name was Abigail. Chn.: 1. Elizabeth, b. 1768, m. Benjamin Toucee. II. Anne, b. 1770, m. James Wiggins. III. Eliakim married Martha Onion and received lots 57 and 58 in 1804. He removed about 1828.

Jesse Curricomb in 1818 inherited lots 120 and 121, with his brother Eliakim, David Toucee and the heirs of Anne Wiggins, and he had lot 142 assigned to him in 1824. His wife's name was Phebe, who died before 1834, when her husband and son John removed to Wisconsin. The son was drowned in the Fox River.

"The first emigration of families from Brothertown, N.Y., to Green Bay was in the year 1831...The company of 1831 was composed of nearly forty persons, chiefly the large families of William and Elkanah Dick and Randall Abner. Thomas Commuck and his wife Hannah, Isaac Scippio and David Johnson also went in this party. Of these the following were living in 1895: Barbara Dick, Delila Dick Brushel, Hannah Abner Commuck, Rebecca Abner Johnson, and Elias and David Dick. They made their settlement at Kaukauna on the Fox River, and built their log houses. The land was not the best adapted to farming and they did not intend to remain there. The treaty which gave them a township farther south on the east shore of Winnebago Lake was then pending and was ratified the following year. Hence they had not long to remain, and they moved to their final location in 1832 and 1833."

E.N. Schooner, an old soldier, met with a sad accident, on Monday, falling from a load of wood and striking his head which caused a severe frature of the spine resulting in paralysis of the body below the fracture. Dr. W. Minahan was called but he thinks Schooner's chances for recovery are doubtful. Mr. Schooner served with credit to himself in the war of the rebellion under Gen. Harrison C. Hobart in Co. E of the 21st Wis. His sad accident will be learned with regret by all comrades who knew him.

Feb. 18, 1899 Brothertown Column:

J.H. Kindness and daughter, Dora and Mrs. H. Bostwick, of Chilton, came out yesterday to attend the funeral of E. N. Schooner.

The funeral of Mr. E.N. Schooner, who died on Saturday evening from injuries received in a fall on the 6th inst., took place from the M.E. Church, yesterday, at lo'clock p.m. Rev. J.H. James, officiating. The funeral was attended by a large circle of sympathizing friends with comrades, H.R. Crowell, H. Musket, D. Dick, S. LaPrarie, W.H. Johnson and L.H. Waffle as bearers.

Mr. Schooner was born at Brothertown, N.Y. in 1833, and moved with his parents and settled down here soon after, where he has resided the most of the time since. He was a member of Co. E 21 Wis. Vol. Inf. In his death he leaves a son, daughter, sister and a large circle of near relatives to mourn. It is reported that he was a member of the G.A.R. Post at Plainfield, Portage Co., where he had resided the past two years. The sympathy of the community is

extended to the bereaved relatives in thir great sorrow.

Springfield, Aug 25th .62 Dear Friend

I now try to write you a few lines in Answer to your kind letter which I received 4 days ago but I have not felt like trying to write and in fact I don't now. I am now in the hospital and have been here 8 days today. I am having the typhoid fever though I haven't been so very sick yet only a day, still I am getting pretty weak. But I hope by being careful to get around again. There is 13 in here sick from our Company mostly fevers. D. J. Adams is sick here in the same room with me. All of the Brothertown boys here are in good health I believe. A week ago today poor Ira Wiggins died here in the hospital, he was here 9 days and after he had been here 3 or 4 days he didn't have his senses. They called it the typhoid fever. He was buried with all the usual ceremonies of burying soldiers. There has four died here since I came here but the most of them was wounded men. You say you have enlisted. Well I must say to you to be careful when you go into camp, don't expose yourself any more than you can help. I have got almost sick of Cavalry. I think it is harder upon a man than Infantry. I wish I could get into some Reg't where some Brothertown boys are.

The weather continues hot here yet and fruit is plenty of all kinds but that is all the good it does me. There is no fighting going on anywhere near here lately. But in the N.E. part of the state there has been plenty between the State Militia and the guerillas. I tell you I find some difference in the fare here than the fare you have up there when you are sick.

You never told me how Bill O'Brien got along. I should like to know what kind of a crop was raised on Mrs. Harts farm. But I must close for this time, hoping to hear from you soon. Give my best respects to all your folks.
